

Recalculations - Black Carbon (BC)

Revision of Black Carbon emissions over time:



The small changes within the **National Total reported for 1990 (-0.7 kt | -1.7 %)** are dominated by changes in **NFRs 1.A.3.b i, 1.A.3.b ii and 1.A.4.c ii** together with less significant revisions throughout NFRs 1, 2 and 3.

The most significant relative change occurs for **NFR 2.G with minus 51 %**
