

Recalculations - Benzo[k]Fluoranthene

The small changes within the **National Total reported for 1990 (+0.27 t | +1.66 %)** are dominated by a revision in **NFR 1.B.1.b**.

In addition, several much less significant changes occur throughout NFR 1.
