

## Recalculations - Lead (Pb)

The changes within the **National Total reported for 1990 (-19 kt | -1 %)** are dominated by changes in **NFR 1.A.3.a ii(i) with -19.6 kt or -85 %** together with less significant revisions throughout NFRs 1, 2 and 3.
