

Recalculations - Polyaromatic Hydrocarbons 1 to 4

The strong changes within the **National Total** reported for **1990 (-59 t or -33 %)** are dominated by changes in **NFRs 1.B.1.b (-35 t), 2.A.1 (-6.90 t) and 2.C.3 (-17 t)**.

However, the most significant percental change occurs for **NFR 1.A.3c with plus 164 %**.
