

Recalculations - Benzo[b]Fluoranthene

The small changes within the **National Total** reported for **1990 (+0.54 t or 1.52 %)** are dominated by a revision in **NFR 1.B.1.b with +0.55 t** together with much less significant changes throughout NFR 1.
