

# Recalculations - Dioxines & Furanes (PCDD/F)

The significant changes within the **National Total** reported for **1990 (-9 g or -1.11 %)** are by far dominated by a **revision in NFR 5.E (-9.04 g)** together with several **smaller changes throughout NFR 1.A**.
