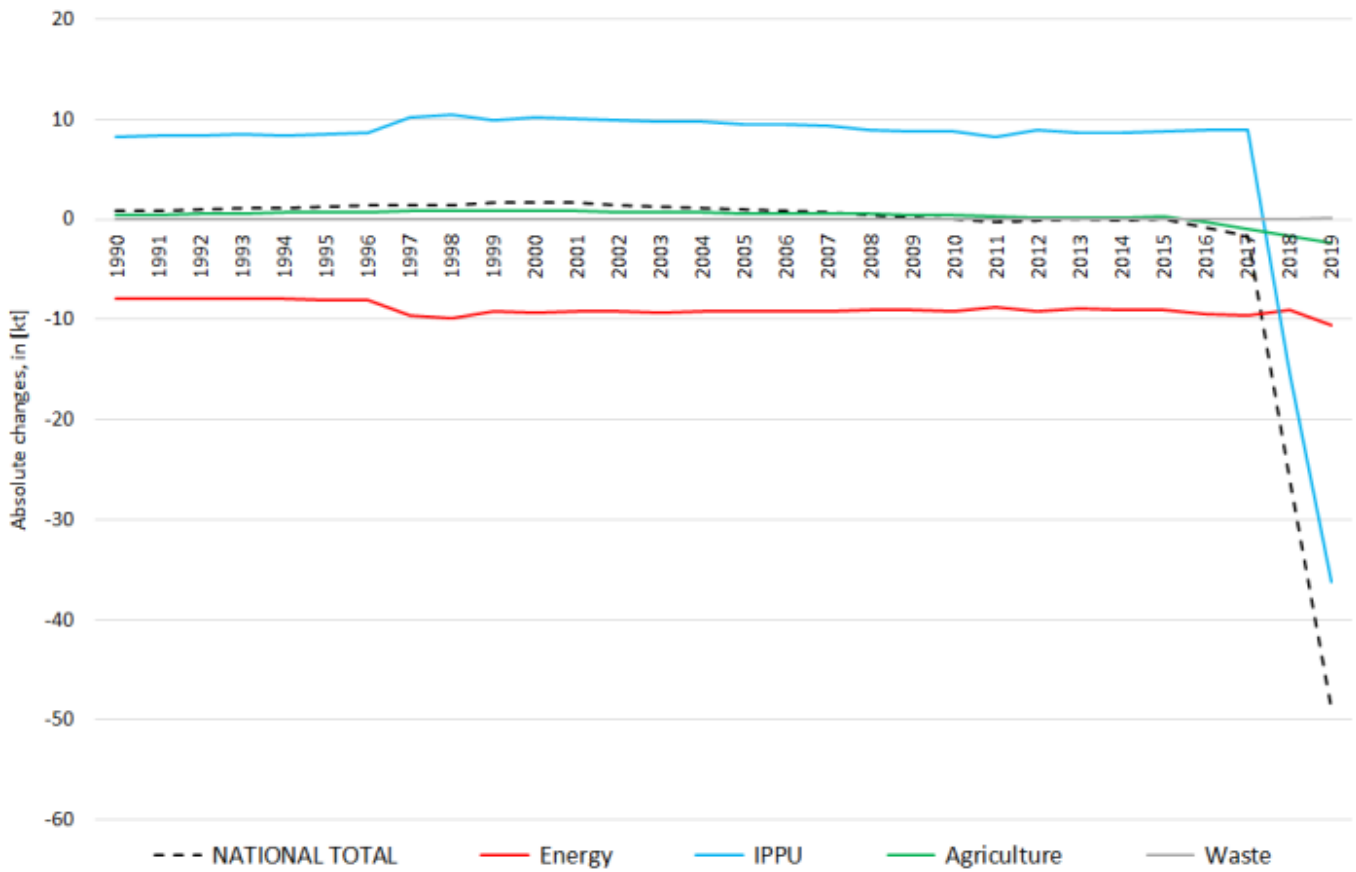
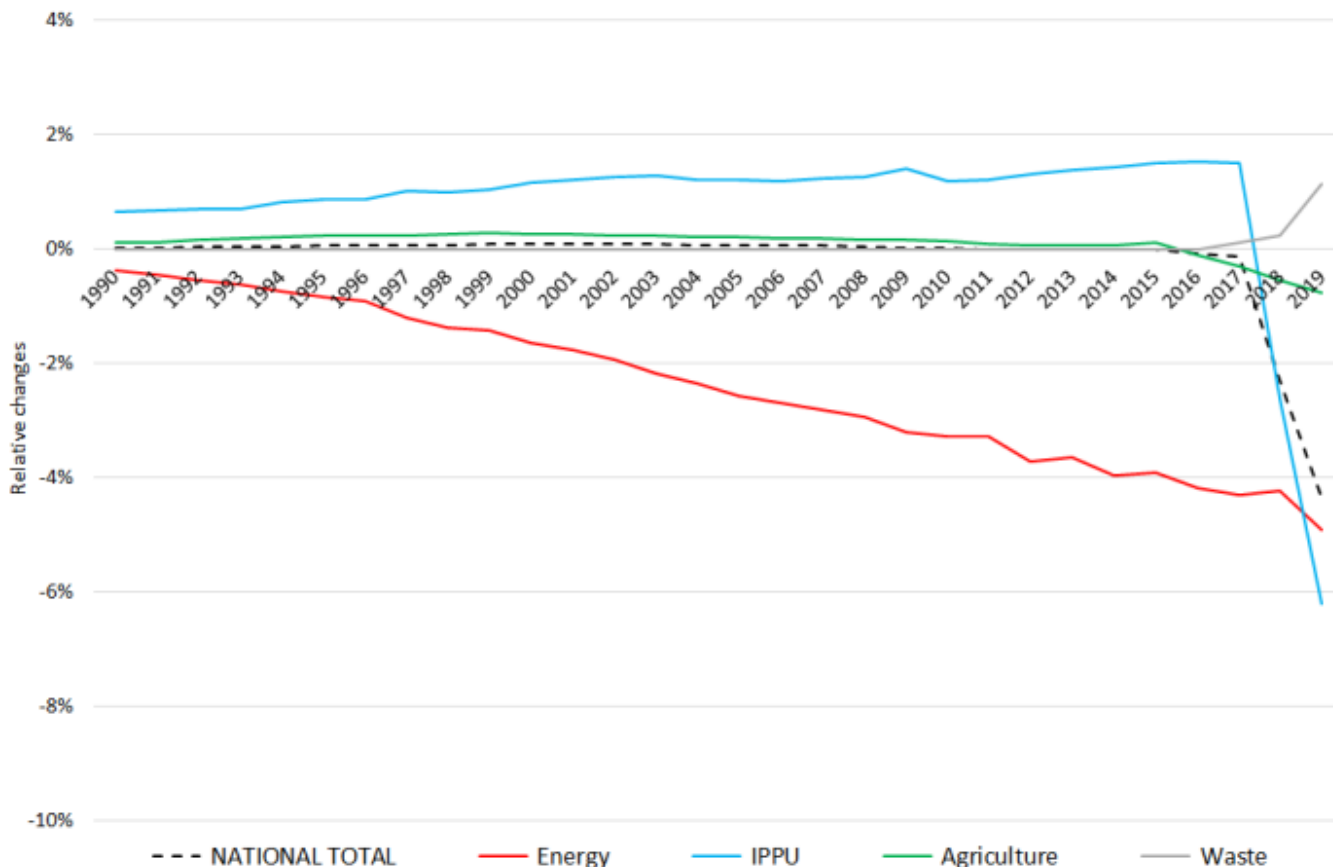


Recalculations - Non-Methane Volatile Organic Compounds

Revision of NMVOC emissions over time





The insignificant changes within the **National Total reported for 1990 (+0.73 kt | +0.02 %)** are dominated by a re-allocation of **8.09 kt** of NMVOCs from NFR sub-categorie **1.B.2.a iv** to **2.B.10.b**, with the strongest percental change occurring for **1.A.4.c iii** with minus 55 %.
