

# Recalculations - Particulate Matter <10µm

## Revision of PM<sub>10</sub> emissions over time:



Changes within the **National Total reported for 1995 (-9.7 kt | -2.7 %)** are dominated by changes in **NFR 2.G (- 8.81 kt or -58.7 %)** together with less significant revisions throughout NFRs 1, 2 and 3.

The most significant relative change occurs for **NFR 2.C.7.c with minus 73.4 %**.
