Changes within the **National Total** reported for **1995 (-3.96 kt or -1.14 %)** are dominated by changes in NFR **1.A.3.d ii (-4.09 kt)** and **1.A.3.c (+0.82 kt)** together with less significant revisions throughout NFRs 1 and 2.
