

Recalculations - Particulate Matter <10µm

The changes within the **National Total** reported for **1995 (+4.74 kt or +1.38 %)** are dominated by changes in **NFR 3.D.c with +5,67 kt** together with less significant revisions throughout NFRs 1 and 2.

With a plus of 35%, the revision in 3.D.c is the most significant percental revision.
