

Recalculations - Particulate Matter <2.5µm

The changes within the **National Total** reported for **1995 (-3.26 kt or -1.58 %)** are again dominated by changes in NFRs **1.A.3.d ii (-3.73 kt)** and **1.A.3.c (+0.73 kt)** together with a variety of more or less significant revisions throughout NFRs 1 and 2.

The most significant percental change occurs for **NFR 1.A.4.b ii with plus 56 %**.
