

Recalculations - Dioxines & Furanes (PCDD/F)

The small changes within the **National Total reported for 1990 (-1.05 g | -0.13 %)** result from several small changes throughout **NFR 1.A**.

The most significant percental change occurs for **NFR 1.A.3.d ii with plus 74 %**.
