

## Welcome to the German Informative Inventory Report 2025 (IIR 2025)!

This report covers the preparation, maintenance, and improvement of the German air pollutant emission inventory.

Emission estimates are provided for the **time series from 1990 to 2023**, with exceptions for **fine particulate matter** with aerodynamic diameters of  $\leq 2.5\mu\text{m}$  ( $\text{PM}_{2.5}$ ) or  $\leq 10\mu\text{m}$  ( $\text{PM}_{10}$ ) respectively with data **as of 1995**, and **black carbon (BC)** with data **as of 2000**.
