

The small changes within the **National Total** reported for **1995 (-1.31 kt or -0.66 %)** are dominated by revisions in NFR sub-categories **1.A.3.b vi (+1.55 kt)** and **1.A.3.d ii (-2.71 kt)** together with a variety of less significant revisions throughout NFRs 1 and 2. In addition, for NFR 2.D.3.c, particulate matter emissions are reported for the first time.

The most significant percental change occurs for **1.A.4.c iii with -81.53%**.

The small changes within the **National Total** reported for **2023 (-1.31 kt or -0.66 %)** are dominated by revisions in NFR sub-categories **1.A.3.b vi (+1.55 kt)** and **1.A.3.d ii (-2.71 kt)** together with a variety of less significant revisions throughout NFRs 1 and 2. In addition, for NFR 2.D.3.c, particulate matter emissions are reported for the first time.

The most significant percental change occurs for **1.A.4.c iii with -81.53%**.
